President's Message: (Danielle Silverstein) Danielle shared highlights from the Board meeting held prior to this meeting.

Secretary Report: (Robin Murphy) January Minutes were posted on the Website by Jill Faulmann. Jan made the motion to approve the minutes as written. Darlene seconded. Motion passed unanimously.

- In January reports are to be sent to AKC, if you have any current changes, please let the Jill Faulmann, Robin Murphy and/or Darlene Brushwein know, and they all need to update current records.

AKC Delegate Report:

- AKC Delegate Report, Jill Faulmann: Current Statistics form AKC.
 - Reason for events being down??? Obedience events due to facility difficulties, training required based basics, population getting older, increase AKC fees = increased entry fees.
 - SDTC is fortunate our Trials fill and we currently have a great facility at the Cash's.
- Many fines for late submission from superintendents and Secretaries.

- We have never had that happen because of great due diligence at getting paperwork done right away and back to the AKC within the short time frame.
- AKC has added so many more events that, naturally, it's pulling entries from each other.
 - There are 54 (maybe it's 57) titles in scent work? Imagine how much money that takes.
 - In rally, once a dog is going for their champion title, they must enter three classes on the same day. That's easily \$95 or more a trial. At my club's 3 day cluster, that's \$285 for one dog in one sport over the weekend.

Report of AKC Delegate Committee Meetings December 2025:

- Companion Events: Subcommittee to look at beginner novice and companion dogs in an effort to make these events friendlier and welcoming.
- Entries are down. Looking at preferred novice title.
- Subcommittee looking at ways to show how Obedience can be helpful in other aspects of the sport. The goal is to show those who come to the sport, for instance Scent Work, Fast CAT®, how Obedience training can help with their dog's behavior.
- As of June 20, 2025, the Sports: Events department at AKC showed a loss of nearly \$2.2M. For years, the surplus revenue from Registration has defrayed the expense gap between what Sports and Events generates and what they spend to keep going. IT is a large part of the expense with the cost of proper IT personnel to fill the gaps. This is the need to increase fees for entries.

 - Jill made the motion that the Delegate position be transferred to Lori Sage. Jan seconded. The motion passed unanimously.
 - Jill will move forward with the necessary paperwork.
